Welcome to INROLL, the Newburgh Enlarged City School District Employee Benefits Portal-your online employee benefits website! Beginning on 10/1/16, this 24/7 website will be able to provide you with an efficient way to enroll and make changes to your health insurance plan.

You will be able to enroll or decline coverage during the District's open enrollment periods; however you will also be able to make changes to your insurance (ie. Dependents and mailing address) at any time.

In the INROLL portal, you can also obtain information and answers to your questions regarding your 403B Retirement Benefit and other benefit plans.

Our goal is to empower you through this tool to meet your specific needs, as well as enhance your understanding of our benefit programs. Specifically, you will have access to the various benefit summaries, forms and links to important sites.


Your benefits are an important part of your total compensation, so we invite you to familiarize yourself with details of these plans and encourage you to seek clarification when necessary.

Important INROLL Log in information: Please go to <https://www.inrollplus.com> to log in to INROLL. If you were hired prior to September 1st, 2016, you will use your last name, last four digits of your social security number and the default date of birth **09/01/1980** when logging into the system for the first time. You will then be able to create a User Name/Password and update your profile information with your correct date of birth. If you were hired after September 1st, 2016, you should use your last name, last four digits of your social security number and your actual date of birth when logging into the system for the first time.

INROLL and ACA- All full-time employees will be required to log into the INROLL system during the months of October-November to verify that they are either enrolled in a District health insurance plan, participate in the Health Insurance Buy-Out or have waived both insurance and the buy-out option.

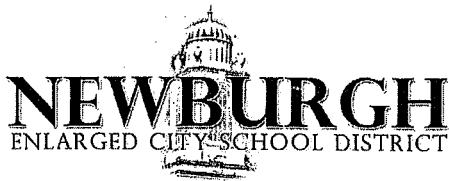
