New registrants and currently registered students who have moved are required to file <u>in person</u> at the Office of Registration, located at 124 Grand Street, Newburgh, between the hours of 8:00 AM and 3:30 PM and provide the following:

- Birth Certificate (In accordance with New York State Education Law student must be 5 years of age prior to December 1, 2018 to be eligible for transportation)
- Picture ID of parent/guardian
- Immunization record and recent Physical Examination
- Proof of residency (utility bill, rental agreement or mortgage statement)

If the student requires an alternate stop/baby sitter, an Alternate Stop Form must be completed as well. Forms are available on the transportation page of the District website (<u>www.newburghschools.org</u>) or at the Transportation Department.

Parents/guardians are reminded that <u>signed</u> applications must be received by the Transportation Office no later than <u>April 1, 2020</u> for a student to be eligible for bus transportation in September 2020.
